### Emissions reduction targets

Our targets are approved by the Science Based Target initiative.

#### Overall Net Zero Target

Capita PLC commits to reach net-zero greenhouse gas emissions across the value chain by 2045.

#### Near Term Targets

Capita PLC commits to reduce absolute scope 1 and 2 GHG emissions 46.2% by 2030 from a 2019 base year.  
Capita PLC also commits to reduce absolute scope 3 GHG emissions from business travel 46.2% within the same timeframe.  
Capita PLC further commits that 50% of its suppliers by spend covering purchased goods and services, capital goods, and upstream transportation and distribution will have science based targets by 2025.

#### Long Term Targets

Capita PLC commits to reduce absolute scope 1 and 2 GHG emissions 90% by 2045 from a 2019 base year.  
Capita PLC also commits to reduce absolute scope 3 GHG emissions 90% within the same timeframe.

### Carbon Reduction Projects

#### Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2019 baseline. The carbon emission reduction achieved by these schemes equates to a 54% reduction against the 2019 baseline and the measures will be in effect when performing the contract which is:-

Consolidation of our property estate to ensure it is the right size for our business  
Energy efficiency review calls for our most energy intensive properties  
Procurement of 100% renewable electricity, or engagement with landlords where they are responsible  
Decarbonisation of heating systems on long term leases  
Use of digital first collaboration tools  
Only hybrid or fully electric cars available for car fleet  
Consultation with clients on feasibility of electric vehicles for operational fleet  
Investment in supplier management platform to increase visibility and accuracy of supplier emissions data  
Responsible AI procurement  
Explore opportunities for use of circular economy with clients

In the future we hope to implement further measures such as:  
Change of short term leases to EPC B or above upon termination of lease  
Prioritised supplier engagement  
Prioritisation of public transport for short journeys
